Break into spring with the beauty of Wisconsin's Northwoods and come ride the **RASTA Rally**. New this year will be an **Expert class that requires two laps of our 12.5 mile course** that has over 60% technical single track. **Sport riders will complete 1-lap of the 12.5 mile course and Citizen Racers will race on a 7 mile double track course.** From the infamous "Wart" to log bridges this is a mountain bike race for all levels of bikers. The **RASTA Rally Mountain Bike** race is fast becoming a destination race with racers coming from Illinois, Minnesota, Michigan and Wisconsin. Last year the RASTA Rally had 150 racers and the WORS series Crystal Lake Classic had over 600 racers at the Mud Lake course and at Camp Tesomas. RASTA maintains the mountain bike, snowshoe, and hiking trails at Washburn Lake, Mud Lake, and Hanson Lake Trails in Oneida County. Several miles of mountain bike and snowshoe trails were upgraded and new trails constructed at Mud Lake and Washburn Lake last summer. Proceeds from the RASTA Rally support our maintenance activities and fund the purchase of leaf blowers, power trimmers, hand tools, signs and trail markers.

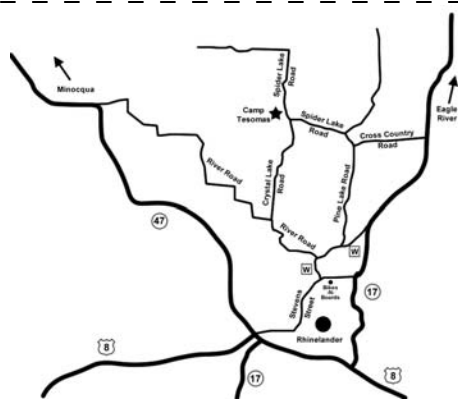
